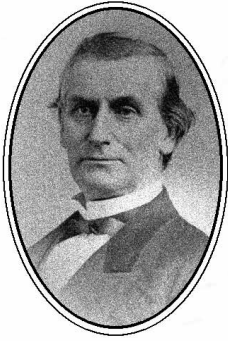


The Reverend Charles Frederick Allen was the first full-time president of the University of Maine (1871-1879). A native of Norridgewock, Maine, he was a graduate of Bowdoin College and Wesleyan University. Well-known for his success in teaching and the ministry, Dr. Allen served on the examining committee for students



before becoming president. He devoted his presidency to building the new campus, strengthening curricula, elevating academic standards, and communicating the value of higher education at the University. Envisioning a long and promising future for the institution, Dr. Allen sought to assure that the University would always reflect well on the State of Maine and be worthy of the public's high regard and support.
